That Jeffery Joseph Mcdaniel did in Richland County, on or December 12, 2015, manufacture, or did aid, abet, attempt or conspire to manufacture, a quantity of Methamphetamine (Crank), a controlled substance under provisions of Section 44-53-110, et. seq., S. C. Code of Laws, 1976, as amended, such manufacturing not having been authorized by law, to wit: in that he was in possession of materials, chemicals, and ingredients used in the manufacturing of Methamphetamines at 829 Ohio St., and such not being a first offense, in violation of Section 44-53-375(B), S.
