

State in this Court on July 18, 2016. Counsel filed the initial brief of appellant and designation of matter in the case of State v. Daniel Maurice Frasier in this Court on July 13, 2016. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Steven Rogers v. State in this Court on July 13, 2016. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Ruben Silva-Aguilar v. State in this Court on June 21, 2016. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Arteasa Whitlock v. State in this Court on June 20, 2016.

3. This request is made in good faith, and not for purposes of delay. Counsel is striving to limit the number of extensions requested. Counsel is attempting to complete the cases with the most number of extensions first.


4. As indicated by her consent below, counsel for the state graciously consents to or does not oppose this request.
