
Dear Hilda:

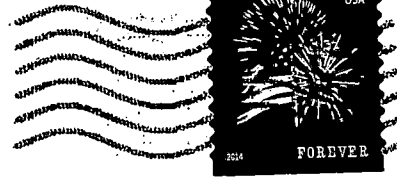
