

ORDER

After careful review of the filings in this appeal, we recall the remittitur and reinstate the appeal because the appeal was dismissed and remitted in error. 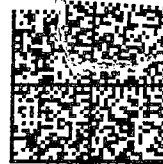

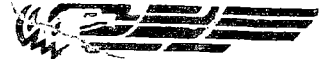
