Joint Motion for an Extension of Time


On July 27, 2016, the Panel issued Unpublished Opinion No. 2016-UP-387 in the above-captioned appeal and affirmed in part and reversed in part the judgment of the circuit court. Pursuant to Rules 221(a) and 240 of the South Carolina Appellate Court Rules, Appellants Regions Bank and Robyn Clevinger and Respondent Lydia Cook jointly request an extension to the deadline to file the parties' respective Petitions for Rehearing. This the second request for an extension of this deadline.

The basis for this motion is the parties have agreed to a settlement in this matter but need the additional time to execute the settlement agreement and enter the dismissal with this court. The parties will be unable to do so by the current deadline of August 26, 2016, because of the previously scheduled vacations for counsel for Regions Bank that conflict with the current deadline.

The parties jointly request a fifteen (15) day extension of time to file their respective Petitions for Rehearing. The extended deadline would be September 12, 2016. This extension will allow the parties the time needed to complete settlement and dismiss this appeal.

Therefore, the parties request that this Court enter an order extending the deadline for the Petitions for Rehearing until September 12, 2016. The parties request that the current deadline be held in abeyance while the Court considers this request.




