



COMES NOW Helen, the living woman on a Court of Record as the Petitioner for the protection of rights. This court has come to review the facts, record, and process in the case listed above In The Court of Common Pleas and Master In Equity County of Richland, State of South Carolina by Judge Joseph Strickland signing orders. Upon careful review the following errors have occurred in this case:

1. This administrative foreclosure proceeding is an illegal an unlawful, because it is a violation of the United States Constitution, in which the United States Constitution is outside of any Administrative courts expertise, pursuant to Charles L Hill vs. SEC.
2. The Judge involving this administrative proceeding does not have any delegated authority from the Executive branch of government, it violates the Appointments Clause of Article II as the Administrative Law Judge (ALJ) is an inferior officer and he was not appointed by the President, the courts of law, or a department head. See U.S. Const. art. II, § 2, cl. 2.
3. This case is void due to the Plaintiffs attorney entered a void summons and complaint on or about, in breach of the public trust, outside of the Courts ministerial duty, and without proof of delegation of authority or jurisdiction of any kind, and IN BREACH OF THE PUBLIC TRUST AND IN VIOLATION OF THE JUDICIAL CODE OF ETHICS.
4. I, Helen Valencia Thomas is a beneficiary of the Public Trust and holds a Superior Claim, I am the general executor of my own estate. (See Exhibit 1)
5. Plaintiff and Attorneys and all court officials are public officers and agents to the UNITED STATES-a federal corporation as defined in 28 U.S.C. 1746 are Trustees and owe a Fiduciary duty to me. See 63C Am.Jur.2d, Public Officers and Employees. (See Exhibit 2)
6. I was never informed that there was an escrow account open in this court,that needed to be settled and close. This is breach of the Public Trust. (See Exhibit 2)

7. The Plaintiff and its Attorney including but not limited to all court officers are acting in fraud and in violation of God's covenant, and outside the decedents will by attempting to enforce an unlawful lien on said real and personal property of my estate, IN VIOLATION OF 17 C.F.R. 450 et. seq, and the Holy Covenant of the Creator God (Amu)
8. Fraud upon the Court initiated by Plaintiff's attorney Roger and Townsend, then picked up by Brock & Scott /Chad Burgess as counsel for Plaintiff, [DEUTSCHE BANK NATIONAL TRUST COMPANY AS TRUSTEE FOR SOUNDVIEW HOME LOAN TRUST 2006-1 ASSET-BACKED CERTIFICATES, SERIES 2006-1] , Voids the entire proceeding.
9. "It is axiomatic that fraud vitiates everything". In re Village of Willowbrook, 37 Ill. App.2d 393 (1962), People ex rel. Chicago Bar Ass'n v. Gilmore, 345 Ill. 28,177 N.E. 710 (1931).
10. It is the inherent power of the Court to expunge from its records void acts of which it has knowledge from its records. See Evans v. Corporate Services, 207 Ill.App.3d 297,565 N.E.2d 724(2nd Dist.1990). See also R.W. Sawant & Co. v. Allied Programs Corp., 111 Ill. 2d 304,309, 489 N.E.2d 1360(1994)
11. "A Judge is not a court; he is under law an officer of the court, and he must not engage in any action to deceive the court", Bulloch v. United States, 763 F.2d 1115,1121 (10th Cir. 1985). Judge Roger M. Young and Ralph P. Stroman, The Judge has engaged in actions to deceive the court.
12. Fraud upon the court exists "where the judge has not performed his judicial duties" In this matter Judge Joseph Strickland, never had jurisdiction from the beginning. See People v. Streeper, 121 Ill.2d 204, 145 N.E.2d 625 1957X". The jurisdiction of the court must be determined as of the commencement of the action.
13. The Court of Common Pleas /Master In Equity, IS A CRIMINAL ENTERPRISE , see U.S. v. Murphy, 768 F.2d 1518,1531 (7th Cir. 1985) and Bracey v. Gramley, 519 U.S. 1074,117 S.Ct. 726 (1997).
14. This Court is under the direct supervision of a Judge known to have acted without jurisdiction.
15. Judge Joseph Strickland is acting without jurisdiction, and is in conflict with the Federal Constitution, and has subjected himself to the consequences of his actions. See Scheuer v. Rhodes, 416 U.S. 232, 94 S. Ct. 1683,1687(1974).
16. Judge Joseph Strickland as a state officer acting without jurisdiction, or acts to enforce a void summons and complaint and orders, he became a trespasser of the law and are engaged in treason. See Yates v. Village of Hoffman Estates Illinois, 209 F. Supp. 757 (N.D. Ill. 1962), U.S. v. Will,449 U.S. 200,216,101 S. Ct. 471,66 L.Ed.2d 392,406 (1980), Cohens v. Virginia, 19 U.S. (6 Wheat) 264,404, 5 L. Ed. 257 (1821).

17. Judge Joseph Strickland, is in conflict with the Supreme Court holding that a Judge has no such jurisdiction, "then he and those who advise and act with him, or execute his process, are trespassers." Von Ketder et al. v. Johnson, 57 111. 109 (1870). Also see Elliot v. Piersol, 1 Pet. 328,340, 26 U.S. 328, 340 (1828) and The People v. Brewer, 128 111. 472,483 (1928).
18. All state officers acting in regard to this matter are in violation of their oaths of office for failure to discharge their duties to uphold the Constitution of and for United States of America.
19. Additionally, ANY JUDGE THAT ACTS in regards to this instant matter will be acting as a fiduciary, and in direct violation of the Judicial Canons of this state.

All parties that have been served this Writ must file a Statement of Claim and their Authority for their Claim within 5 days of receipt of this writ, or the silence by all listed respondents will be a confession of judgement for the release and collateral estoppel of all alleged claims by all listed Respondents.

All answers must be pursuant to Public Law 94-550, "...under oath and affirmation, to be admissible under Court Records". Additionally, If you do not rebut this affidavit by Counter-Affidavit, in the required time given, this Writ will act as a Self-Executing Judgment against all parties that were served, hereby arresting the said Void Summons and Complaint, Summary Judgment and dismissing this case with prejudice and the removal of foreclosure from my credit report. As a result of your silence you give Affiant permission to execute Writs on all parties served on behalf of all entities in regards to the matters listed herein, in accordance with Etna Casualty & Surety CO. of Hartford, Conn, v. Board of Supervisors of Warren County, 160 Va. 11, 168 S.E. 617, 629.

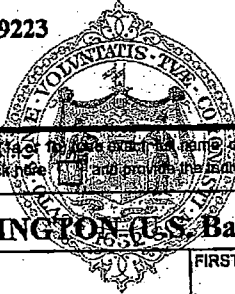

## 63c Am Jur 2d Public Officers and Employees

63C Am.Jur.2d, Public Officers and Employees, §247 “As expressed otherwise, the powers delegated to a public officer are held in trust for the people and are to be exercised in behalf of the government or of all citizens who may need the intervention of the officer. [1] Furthermore, the view has been expressed that all public officers, within whatever branch and whatever level of government, and whatever be their private vocations, are trustees of the people, and accordingly labor under every disability and prohibition imposed by law upon trustees relative to the making of personal financial gain from a discharge of their trusts. [2] That is, a public officer occupies a fiduciary relationship to the political entity on whose behalf he or she serves. [3] and owes a fiduciary duty to the public. [4] It has been said that the fiduciary responsibilities of a public officer cannot be less than those of a private individual. [5] Furthermore, it has been stated that any enterprise undertaken by the public official which tends to weaken public confidence and undermine the sense of security for individual rights is against public policy.[6]” [63C Am.Jur.2d, Public Officers and Employees, §247] [1] State ex rel. Nagle v Sullivan, 98 Mont 425, 40 P2d 995, 99 ALR 321, Jersey City v Hague, 18 NJ 584, 115 A2d 8. [2] Georgia Dep't of Human Resources v Sistrunk, 249 Ga 543, 291 SE2d 524. 
