At a Court of General Sessions, convened on February 2015, the Grand Jurors of Lexington County present upon their oath:

That **Larry L Durney** did, in Lexington County, South Carolina, on or about November 12, 2013, falsely make, forge, or counterfeit; cause or procure to be falsely made, forged, or counterfeited; or willfully act or assist in the false making, forging, or counterfeiting of any writing or instrument of writing; utter or publish as true any false, forged, or counterfeited writing or instrument of writing; or willingly act or assist in any of the premises, with an intention to defraud any person, to wit: did publish a forged check #001126 in the amount of \$100 drawn on the Wells Fargo Bank account of Hartman Hall Child Development Center, such having a value of less than ten thousand (\$10,000) dollars, in violation of §16-13-0010 of the South Carolina Code of Laws of 1976, as amended.
