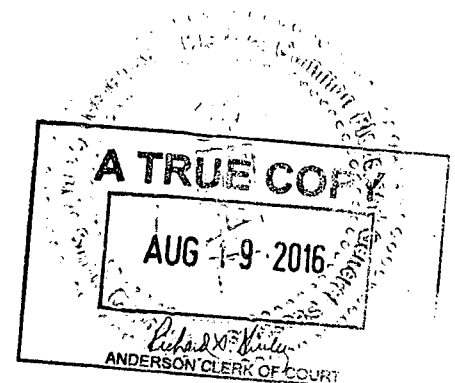
Factual Background:

Timothy Bryan Cason appeared before the Honorable R. Ferrell Cothran, Jr. at a Violation of Probation hearing. He was on probation for Possession of Methamphetamine, and the violation allegations were that he gave his agent a false address which came to light during a home visit conducted on February 29, 2016, that he failed to pay his supervision fee, resulting in an arrearage of \$200.00, that he had a \$405.00 arrearage for failing to pay the Public Defender Fund, and that he failed to follow the advice and instructions of the agent.

At his initial intake meeting on July 22, 2016, and during an interview on August 9, 2016 to review the 1106 form provided by Probation, Pardon, and Parole, Mr. Cason advised his attorney that his issues were all related to his methamphetamine abuse and requested that counsel seek inpatient treatment as an alternative to the full revocation his agent was seeking. Judge Cothran, after hearing from both Probation, Pardon, and Parole and the Assistant Public Defender, sentenced Mr. Cason to nine months and terminated his probation. Mr. Cason had served only sixteen days of his three year sentence at the time his probation was revoked.

Issues for Review:

This appeal is being filed at the request of Mr. Timothy Cason. There are no legal issues which warrant a review.



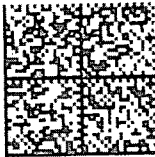

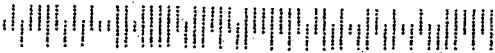
