

Dear Ms. Allen:

I am in receipt of a copy of a letter from the McDaniel Law Firm regarding the above referenced case and their request for a transcript. Mr. McDaniel's firm did write me in May of this year requesting a transcript, and I responded via email on May 26 that advanced payment was required prior to transcript production. I never heard from them again until I contacted their law office in late May and inquired if they still wanted the transcript. A copy of this email is attached for your review.

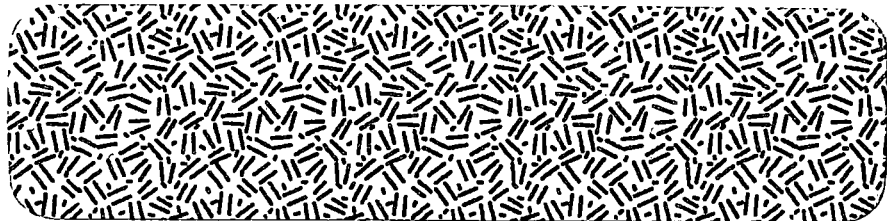
