This is to acknowledge that on August 1, 2016, I received your e-mail dated August 1, 2016 clarifying that your request for the Transcript of Record in the above matter should not include any voir dire or jury selection. I have revised my original estimate based on your request. The transcript will be approximately 185 pages.

Rule 607 provides that the rate of \$3.25 per page shall be charged. Based on this rate, the estimated cost will be \$601.25. Upon receipt of your check in the amount of \$601.25, I will be able to place your request in line for production. If the transcript is less than 185 pages, I will refund the difference to you upon delivery of the transcript. If you desire to cancel the request for the transcript, a cancellation request must be made in writing. You will be responsible for payment of any portion of the transcript that has been completed.

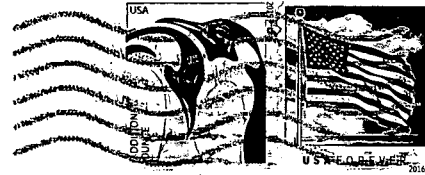
