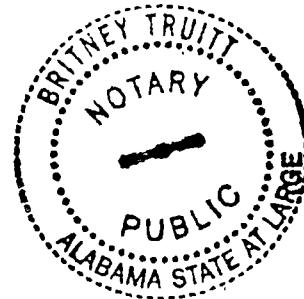

Upon reviewing your amended notice of appeal, the following deficiencies have been noted under the South Carolina Appellate Court Rules (SCACR), and must be corrected within ten (10) days of the date of this letter or your appeal will be dismissed:

- The accompanying proof of service is not in compliance with the SCACR. Your proof of service should be substantially in the format shown by Form 7 in Appendix C to part II of the SCACR. It does not specifically name the attorney of record.
- The caption/title does not comply with Rule 267(a), SCACR. Specifically, it still does not contain the attorney information required by the Court's May 27, 2016, letter.
- The amended notice of appeal is formatted like a proof of service and does not give the date of the order on appeal or the date the order was received.
