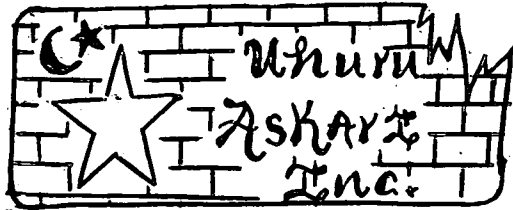



Dear Ms. Jones:



2165 I KNOW that you're probably surprised and a little perplexed/befuddled to be receiving a letter from someone who's IN PRISON but..... All I ask is that you call on your memory to take you back to 22 June 2015 when you came to the Greenville Hospital to help me deal with what happened to me at around 1 AM on the 20 June 2015 at Perry Correctional Institution (PCI). I don't know how much of that day YOU'LL remember/recall, but for "me"..... It's one of the MOST MEMORABLE days of my life..... I've replayed it at least a million times in my head..... I've had dreams and NIGHTMARES about it..... And therefore I remember it with "Vivid Details". 2165

2165 It was on that horrible day that I had to get a "Rape Kit" done on me, and for a guy like myself who's been in prison since 20 August 1997 and housed in South Carolina's WORST ^{housing units}..... I'd never in a "Hundred Million Years" ever have thought that I'd have to under-
LIKE THAT because some SICK and sadistic

officers currently employed by the South Carolina Department Of Corrections (SCDC) thought that they'd "Teach Me A Lesson"..... Dehumanize me.....

.... Try to take the fight out of me..... ^(like they used to do on the planets) Try to ^{of us} take my MANHOOD..... And turn me into a docile zombie by holding me down after spraying me with 200-500 grams of chemical munitions, while one of them stuck me in my butt a few times with his hands or the end of a pair of handcuffs. 2165

2165 THAT Ms. Jones is a feeling that NO ONE (Prisoner or not) should ever experience, and since it's happened to me I'm ashamed to admit that I've continually caught myself thinking about suicide more because the nightmares that I have..... They're nightmares where I'm held down by men while one rapes me (Or sometimes more than one rapes me)...



.... And they've causing me to constantly have a TUG OF WAR type of battle between wanting to kill all officers and wanting to "End My Life" just so the nightmares will stop. And it seems like every single time I think I've had the LAST ONE (Because days or weeks will go by and I won't have one) I'll have one so BAD that I wake up infuriated Sometimes crying Hurt Down-trodden HOPELESS and wondering "why" this happened to me and what I could/should have done to avoid it, ^{was}

^{was} I've been in alot And I do mean ALOT? Of "physical" altercations with correctional officers throughout the 18 Years And 1 Month I've been incarcerated (Thus I've been categorized as a "Hardhead", assaultive inmate, trouble maker, etc.), and therefore I'm no stranger to the BANGS AND BRUISES of getting beat up by five to ten (5-10) men, but Until 20 June 2015 NEVER have I had to deal with dwelling on the fact that I got "overpowered" by "men" to the point they thought they'd "Teach Me A Lesson" by playing on my manhood like that. For a "man" Ms. Jones That's the ULTIMATE humiliation, and no matter what I do or how hard I try, I can't seem to "heal" from that particular type of "Bang And Bruise" to my MIND. ^{was}

~~XXXXXX~~ ^{ZLGT} ^{was} Since talking to you at the hospital that day, all I've encountered is alot of officers who pick at me on the low for talking a stand and exposing what happened to me (And undoubtedly COUNTLESS others "Too Ashamed", and embarrassed to say something) I've encountered "Medical Personnel" who's ONLY OBJECTIVE has been to go out of their way to help cover up what happened I've encountered SCDC staff and administrators who've wantonly going far and beyond to cover up and downplay the severity of what happened (Seemingly because they know I'm a litigator/half-way decent writer and it's probable that I'm going to file some type of civil suit against them) And I've encountered a whole lot of BAD, DARK DAYS wherein all I am capable of thinking about is "death" Mine's Sometimes ALOT of officers' Sometimes both, ^{was}

^{was} I actually had to go on a "Hunger Strike" for sixteen to seventeen (16-17) days (From 22 June 2015 to the 8/9 July 2015) just to get the attention of SCDC's Upper Echelon Administrators and make them get me away from the "hellhole/prison" where this happened at (They "finally" okayed an EMERGENCY TRANSFER and moved me here to McCormick CI back on the 28 July 2015). I went from almost 250lb to 217lb in that time frame, and I'm scared, ashamed and overly reluctant to tell you all of the "thoughts" I had during that time Thoughts that I haven't been able to share with anyone, ^{was}

^{was} Since coming here to this new environment/prison I've adamantly been asking to speak to you or to receive some type of "Sexual Assault Counseling", but all of my cries for HELP have fell on deaf ears, seemingly because

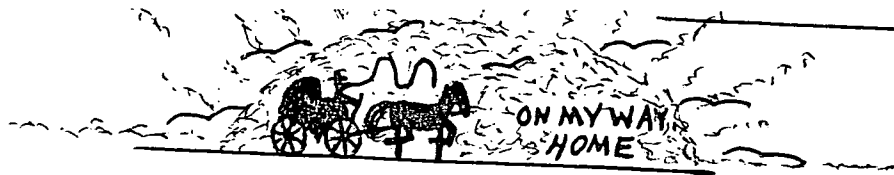
to give me the said counseling would in some way be "admitting" that some of their ROGUE/SICK officers actually did do something REALLY, REALLY cruel and sadistic to me). I've written to Director Bryan P. Stirling, Deputy Director Michael McCall, Deputy Director Lefford Hite, Warden Larry Cartledge (Perry) (McCormick CI), Warden Leroy Cartledge (McCormick CI), Associate Warden James Parker (McCormick CI), Associate Warden Scott Lewis, Major Frank Mursier (McCormick CI) and COUNTLESS others but To date they've refused to give me counseling, ignored my requests, sent me asinine responses to my requests, and/or refused to allow me to call you altogether. 265

265 Which is the reason I'm now reaching out to you and the Julie Valentine Center for some HELP AND ASSISTANCE in doing whatever I have to do to be given some type of counseling for individuals who have been sexually assaulted in some way. I know I'm probably one of VERY FEW (if not the "only") men in prison who's admitted to being overpowered by correctional officers and stuck in the butt at least twice during a SCDC Policy Approved "Use of Force", but that doesn't mean that these people can deny me some type of counseling. It's almost as if they want me to lose it again, hang myself and/or kill some of them so they can have a justifiable reason to sweep this under the rug and NOBODY ever know about it "Outside of SCDC's Infrastructure". 265

265 Knowing that THAT may be one of their sick objectives is another motivating factor that prompts me to pick up this pen and write you (No matter how bad my hand and fingers hurt) Hoping and praying that some how Some way ... You all will be able to help me get the help I NEEDED ... Help that I'm afraid if I don't receive They'll WIN because I'll have a really, REALLY bad day one day and either kill myself or get killed after killing some of them. 265

265 Ms. Jones Up to this point You and the Julie Valentine Center are the ONLY ONES that I've had the courage to tell this much too (Because I know people are going to talk about me behind my back, pick at me, and make me feel like a LSPERR for speaking up), but From this day forward I'm going to write "everybody" I can think of who might be able to help me get some type of counseling and/or therapy Even while INCARCERATED IN PRISON.

265 So, from one hopeless and alone occupant of this small planet to another occupant of the same planet SPREADING helping those who've been sexually assaulted With tears in my eyes and in my heart,



I'm BAGGING you and the Julie Valentine Center to help me, or at least provide me with the names of some organizations who are at liberty to help me. SCDC is a VERY powerful and sometimes "corrupt" infrastructure that has a tendency to "Protect Their Own And Cover Up For Their Own", so I KNOW this ~~is~~ won't be an easy battle but..... I've VOWED that so long as I'm an occupant of this small planet and I'm occupying this body tagged as Robert Louis Garrett Jr. I will "vigorously" do everything I can to get help, and moreso EXPOSE what these sick bastards did to me. RLGJ I used to be a DIS HARD optimist, so I'll pretend to be one now and thank you and this Office in advance for whatever help, cooperation and assistance you may be able to provide me with. While a lot of them held me down one of them stuck me in my anus (Either with his hand/fingers or the end of some handcuffs) Sticking me in my butt is NOT AN SCDC APPROVED PRESSURE POINT to make an inmate stop resisting, so I filed a PRA RTSM and Grievance about the matter. Throughout the dates above NP Enloe (with the assistance of Nurse Lindsey Harvis) refused to let me see a doctor so that my injuries could be reassessed, she refused to give me EFFECTIVE pain medication, and she basically conspired with SCDC staff to HELP COVER UP what happened to me. ALOT of people who work for SCDC are trying to cover this up because they think I'm going to file some civil litigation, but right now all I want is proper medical care and sexual assault counseling/therapy to help me combat my nightmares and thoughts.
