

Respondent Wilmington Savings Fund Society, FSB, d/b/a Christiana Trust as Trustee of the American Mortgage Investment Partners Fund I Trust (“Respondent”) hereby moves for the mandatory taxation of \$1,000 in attorney’s fees against Appellant Melissa Furmanchik. Rule 222(a), SCACR (“Unless otherwise ordered by the appellate court or agreed by the parties, costs shall be taxed against the appellant when the appeal is dismissed or judgment on appeal is affirmed.”)(emphasis added); Rule 222(b), SCACR (“[T]he party shall be entitled to recover an attorney’s fee in an amount which shall be set by order of the Supreme Court.”)(emphasis added); Rule 222(b), SCACR fn. 1 (“By order dated July 24, 1997, the amount of attorney's fee was set at \$1,000.”).

On July 15, 2015, the Court affirmed the Judgment of Foreclosure and Sale that Appellant Melissa Furmanchik appealed from. On August 4, 2016, the South Carolina Supreme Court denied Furmanchik’s Petition for a Writ of Certiorari. Therefore, Respondent is entitled to taxation of \$1,000 in attorney’s fees against Appellant Melissa Furmanchik and respectfully requests an Order of the Court to that effect.

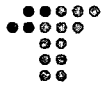


