
Respondent's Motion to File Final Brief Out of Time

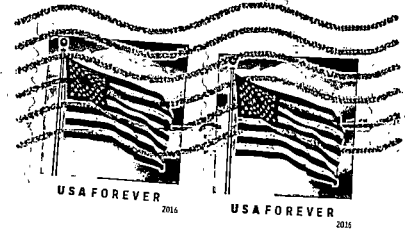
