

ORDER

Appellant filed a notice of appeal and Respondent filed a motion to dismiss the appeal. On June 28, 2016, this court sent Appellant a letter noting several deficiencies with Appellant's appeal, including Appellant's failure to (1) provide a proper proof of service of the notice of appeal and (2) pay the \$100 notice of appeal filing fee. This court ordered Appellant to cure the deficiencies within ten days of the date of the letter and warned that failure to do so may result in the dismissal of the appeal.
