The Court,

This matter comes before the Court on prose Appellant's Statement of Basis for Appeal from a Guilty Plea. Appellant desires to appeal his guilty plea and sentence on the following ground:

"The trial court erred in failing to sentence Appellant per recommended sentence per former trial counsel and state that it would not recommend a sentence of more than ten years."

In March 2013, Appellant entered a plea of guilty to three counts of Assault and Battery First Degree and one count of armed robbery. Sentence was deferred at the time of plea, before the Honorable Judge Letitia H. Verdin in the Richland County

Court of General Sessions. Appellant was represented at this plea by James Cooper, Esquire.

Appellant was sentenced on June 4th, 2014. He received sixteen years on the armed robbery charge, sixteen years on attempted armed robbery charge, and ten years on each of the three counts of assault and battery first degree charges. All sentences were run concurrent and he was given credit for time served while awaiting plea.

The co-defendant pled guilty and no trial was held on his behalf.

Appellant requests this Court to vacate his guilty pleas and sentence and remand for a trial.
