MOTION FOR AN EXTENSION OF TIME
IN WHICH TO FILE THE PETITION FOR WRIT OF
CERTIORARI AND APPENDIX

This motion is made pursuant to the Order of the South Carolina Supreme Court dated March 18, 2009. This is a second request for an extension. In support of this request, counsel shows:

1. The petition for writ of certiorari and appendix are due to be served and filed with the Court today.
2. Counsel for Larold Lee Morris respectfully submits that extraordinary circumstances exist which warrant the granting of an additional extension of time. 

Gardner, Jr. in the Court of Appeals on August 3, 2016. Counsel filed petition for writ of certiorari and the accompanying appendix in the case of Vincent Rice v. State in the Supreme Court on August 3, 2016. Counsel filed petition for writ of certiorari and the accompanying appendix in the case of Termain Cooper v. State in the Supreme Court on July 26, 2016. Counsel filed petition for writ of certiorari to the Court of Appeals in the case of The State v. Jeffrey Davis in the Supreme Court on July 19, 2016. Counsel filed petition for writ of certiorari and the accompanying appendix in the case of Anthony Ogden v. State in the Supreme Court on July 14, 2016.

4. Counsel makes this request in good faith and not for purpose of delay.

5. Counsel for the Attorney General's office has been informed of this request.






