On June 26, 2016 the Appellant received an order of dismissal from the Administrative Law Court ("ALC") dated June 20, 2016 concerning his appeal of the Respondent's inaction to correct it's miscalculation of his Statutorily-earned-sentence-related-credits; Consequently, his Release date has been changed from October 2017, to May 2018 creating a liberty interest. The ALC Dismissed the Appeal prior to the filing of the Appellant's final Brief and as the burden of proof was upon the Appellant the early dismissal prevented him from establishing and meeting the standards for proof.
