4. Therefore, Appellant respectfully moves this Court for an Order extending the time to serve the Record on Appeal.



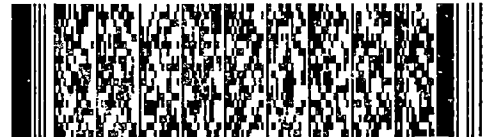
