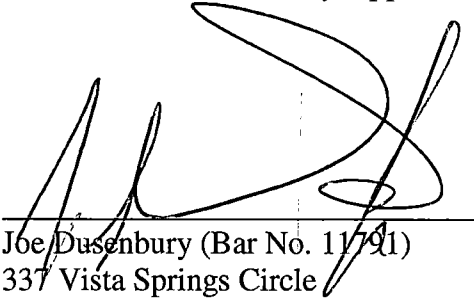

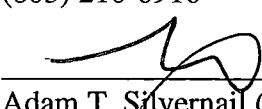
AMENDED NOTICE OF APPEAL
