


Dear Ms. Randolph:

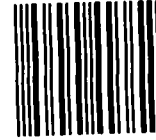
