

## ORDER

Appellant filed a notice of appeal and Respondent filed a motion to dismiss the appeal. On June 28, 2016, this court sent Appellant a letter noting several deficiencies with Appellant's appeal, including Appellant's failure to (1) provide a proper proof of service of the notice of appeal and (2) pay the \$100 notice of appeal filing fee.
