MOTION TO EXTEND TIME TO SUPPLEMENT RECORD


Defendant, by and through undersigned counsel, moves this Court to extend the time to Supplement Record on Appeal and shows the following:



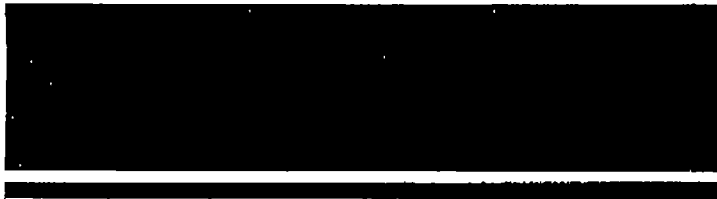
