Dear Ms. Kitchings:

Our firm represents Appellants BI-LO, LLC, and BI-LO, Inc. (collectively "BI-LO"), in the above-referenced matter. Please be advised that we received the transcript of the proceedings below from the court reporter on September 6, 2016.

While, ordinarily, under Rules 208(a)(1) and 209(a), SCACR, receipt of the transcript on September 6th would make BI-LO's initial brief and designation of matter to be included in the record on appeal due by October 6, 2016, it is our understanding that in light of Respondents' pending motion to dismiss the appeal the time limits for perfecting the appeal—including the deadlines for briefing and designating record material—are stayed until the motion has been decided. Rule 240(b), SCACR ("A motion to dismiss an appeal . . . shall . . . automatically stay the time limits for perfecting the appeal until the motion is decided.").

It is, therefore, our understanding that there is no deadline for BI-LO's initial brief and designation as yet. Of course, if this understanding is incorrect, we would greatly appreciate clarification from the Court. And, as always, if you have any questions or concerns or if anything else is required from BI-LO at this time, please just let us know.

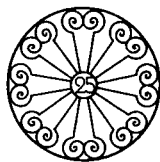
