Please find attached my acknowledgement of receipt of the notice that the argument is set for October 4, 2016.

I would appreciate it if you would confirm that all three (3) appeals, it appears, have been set for one (1) argument with ten (10) minutes for the Appellant; ten (10) minutes to the Respondent; and five (5) minutes for the Appellant in reply. I particularly ask this because my client is the Respondent and Cross-Appellant as to one (1) Commission Order and the Appellant as to another Order. Further, originally we had received a notice of argument on one of these appeals back in June for a 10, 10, and 5 argument and we contacted the Court to confirm whether that was set on that one case, that argument was cancelled.

I would note to the Court that one of these appeals is from a totally separate Order of the Workers' Compensation Commission involving a totally separate Record involving a reinstatement hearing held by Commissioner Beck.

The other appeal by the Defendants and our cross-appeal deal with the final decision of Commissioner Barden and the modification made by the Full Commission Panel and involves a totally separate Record.


