


MOTION FOR CONTINUANCE OF ORAL ARGUMENTS





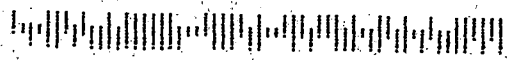
