State in this Court on July 18, 2016. Counsel filed the initial brief of appellant and designation of matter in the case of State v. Daniel Maurice Frasier in this Court on July 13, 2016. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Steven Rogers v. State in this Court on July 13, 2016.



4. As indicated by her consent below, counsel for the state graciously consents to or does not oppose this request.


WHEREFORE, the undersigned counsel would respectfully request a **final thirty-day extension, until October 14, 2016**, in which to file the petition for writ of certiorari and


