

Counsel filed the petition for writ of certiorari to this Court and accompanying appendix In The Matter Of The Care And Treatment Of Kenneth Campbell in the Supreme Court on July 28, 2016. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Ronald Tillman v. State in the Supreme Court on July 25, 2016. Counsel filed the Anders brief of appellant and Record on Appeal in the case of State v. Damonte Rivera in this Court on July 20, 2016. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Richard Kough v. State in the Supreme Court on July 19, 2016. Counsel filed the petition for rehearing in the case of State v. William Travis Calvert in this Court on July 14, 2016.

3. This request is made in good faith, and not for purposes of delay.


4. As indicated by his consent below, counsel for the state graciously consents to or does not oppose this request.




