The undersigned counsel respectfully requests a **final thirty day extension, until October 14, 2016**, in which to file the petition for writ of certiorari and accompanying appendix in the above-referenced case. In support of this motion, counsel would respectfully show the Court the following extraordinary circumstances:

1. The petition for writ of certiorari and accompanying appendix in this case are due to be served and filed today.

2. Counsel filed the petition for writ of certiorari and the accompanying appendix Tommie L. Pixley v. The State of South Carolina with this Court on September 12, 2016. Counsel filed the Johnson petition for writ of certiorari and the accompanying appendix in the case of Oblin Banegas Maldonado v. The State of South Carolina with this Court on September 9, 2016.

Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Charles Henry Davis v. The State of South Carolina with this Court August 12, 2016. Counsel filed the initial brief of appellant and designation of matter in the case of The State of South Carolina v. Austin McQuarters on August 10, 2016 with this court.


3. As indicated by his consent below, counsel for the state does not oppose this request.

4. This request is made in good faith, and not for purposes of delay. Counsel intends to continue to work on the cases with more than three extensions first so that the caseload will hopefully become more manageable in the near future, and less extensions will need to be requested.

WHEREFORE, the undersigned counsel would respectfully request a **final thirty day extension, until October 14, 2016**, in which to file the petition for writ of certiorari and accompanying appendix. Counsel respectfully requests that the time limits for filing the petition for writ of certiorari and accompanying appendix be held in abeyance pending a ruling on this motion.


