Matter.


Appellants’ request for an extension is not intended for purposes of delay.

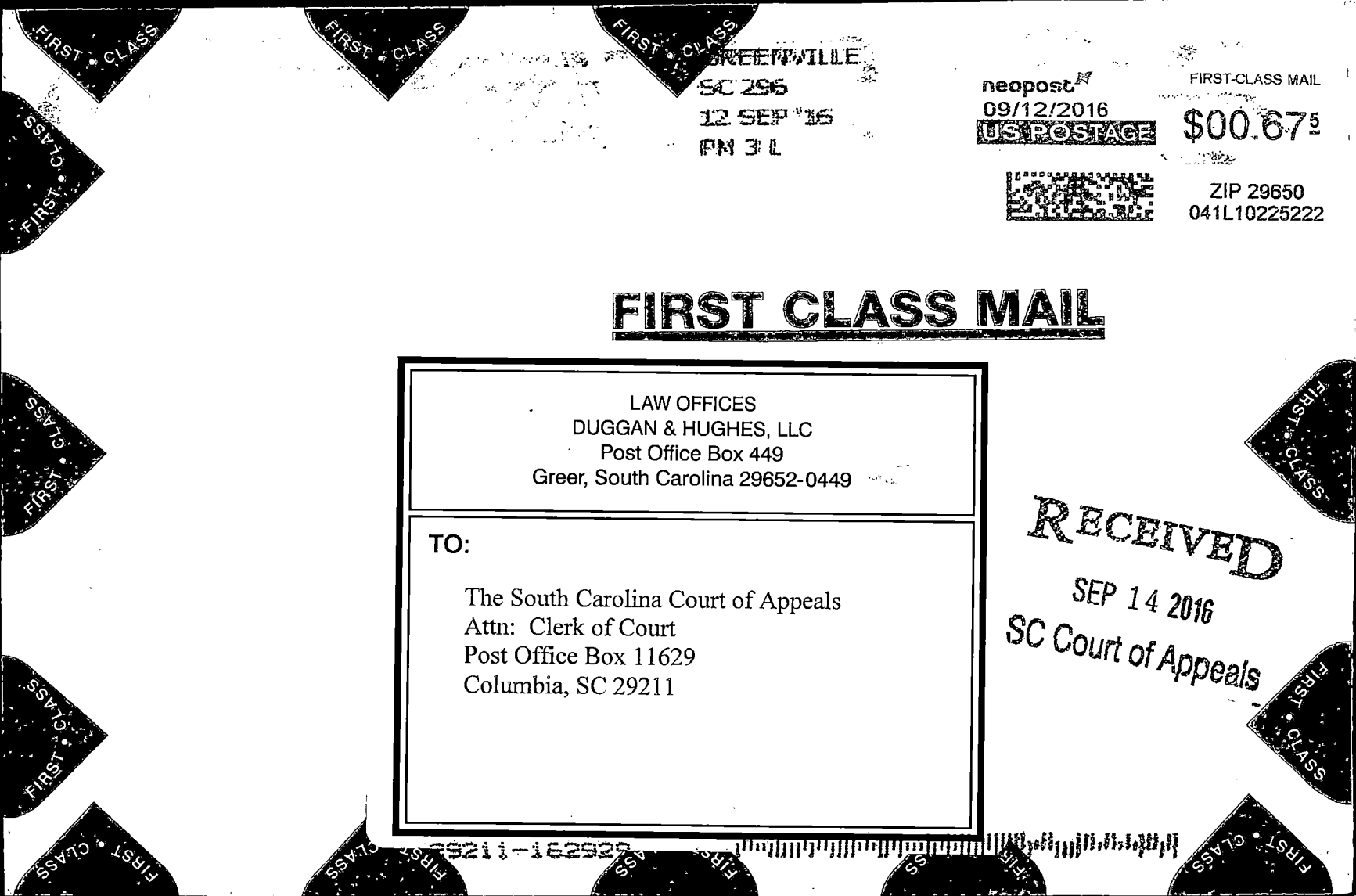
