**MOTION TO FILE AMENDED APPENDIX AND
AMENDED SUPPLEMENTAL APPENDIX**

Counsel for Petitioner hereby moves that this Court amend the Appendix and Supplemental Appendix, pursuant to Rules 210(c) and (f), and Rule 212(b) of the South Carolina Appellate Court Rules. In support of this motion counsel shows the following:

1. The petition for writ of certiorari and accompanying appendix was served and filed on September 6, 2016.
2. Petitioner-Respondent moved to file a Supplemental Appendix on September 9, 2016 to add exhibits from the lower court proceedings.
3. Subsequently, opposing counsel brought to Petitioner-Respondent's attention that the

Appendix was improperly redacted and mistakenly excluded the names of two witnesses, leaving the transcript confusing and difficult to follow. Furthermore, opposing counsel pointed out that a lower court exhibit (Exhibit 19) was not included in the Supplemental Appendix but should have been because it is, in fact, relevant to the appeal.


4. Petitioner-Respondent has amended both the Appendix and the Supplemental Appendix to correct these issues and now moves to replace these documents with the corrected versions.


