MOTION TO AMEND TRANSPORTATION ORDER

1. Two exhibits were received into evidence during the hearing before the Honorable R. Keith Kelly in the hearing on January 20, 2015, in the case of the State v. Annie Jackson, C.A. Number 2014-CP-42-4712. These exhibits were designated **Plaintiff's Exhibit 1** and **Defendant's Exhibit No. 1**.
2. The attorney for the Appellant has previously asked the Court of Appeals to issue an Order, pursuant to S.C.
