MY NAME IS MICHAEL MATEO. I AM CURRENTLY ALMOST 1 YEAR THROUGH A 3-YEAR SENTENCE. I WAS CHARGED W/ 2ND DEGREE ASSAULT/BATTERY. I'M GOING TO DESCRIBE MY SITUATION. THESE DETAILS SHOULD GIVE YOU EVERYTHING YOU NEED TO HELP ME IN FILING FOR AN AMENDS ON MY CASE OR LET ME FILE FOR A POST CONVICTION RELEASE.

MY OLDEST BROTHER, THE VICTIM HAS CLAIMED THAT I'M A PARANOID SCHIZOPHRENIC. HE ALSO CLAIMED THAT I KICKED HIM IN THE HEAD 9X W/ A PAIR OF STEEL TOE BOOTS. THE BOOTS ARE ACTUALLY SUEDE NOT STEEL TOE. ALSO, I HAVE ~~BEEN~~ ~~SCREENED~~ BEEN PSYCHOLOGICALLY SCREENED MORE THAN ONCE. I HAVE NEVER BEEN DIAGNOSED W/ SCHIZOPHRENIA OR PARANOIA. NICK IS ACTUALLY SEEING A PSYCHIATRIST & WAS OUT DURING THE CRIME. I CAN PROVE ALL OF THIS W/ EVIDENCE IN MY PHONE.

NICK CLAIMED I PUNCHED HIM IN THE BACK OF THE HEAD, CAUSING IT TO HIT HIS WINDSHIELD. SAID HE PULLED THE CAR OVER, GRABBED HIS LOADED GUN, STEPPED TO THE REAR OF THE CAR. SAID HE PUT HIS GUN AWAY, THAT I ATTACKED HIM, KICKING HIM 9X W/ STEEL TOE BOOTS. HERE'S WHAT HAPPENED. HE AND I WERE ARGUING, HE WAS OUT (ALCOHOL & PRESCRIPTION ANTI PSYCHOTICS & PAIN KILLERS, INSTIGATING ME.

I PUNCHED HIM IN THE HEAD & HE PULLED OVER, GOT OUT W/
A GUN & POINTED IT AT ME & BEGAN YELLING "GET OUT"
I WAS SCARED FOR MY LIFE AS A PSYCHOPATH ON DRUGS
THREATENED MY LIFE. I REMAINED SEATED AS HIS FINANCE
BEGGED HIM TO PUT THE GUN AWAY. HE CONTINUED TO SCREAM
AT ME. HE'S 6'2 260 LBS. I'M 5'10 100. HE
REACHED THROUGH THE FRONT OF THE CAR PUT THE GUN
DOWN & GRABBED A DAGGER. HE CAME BACK AT ME
THROUGH THE PASSENGER DOOR & POINTED IT AT ME. I
REMAINED SEATED I REMAINED SEATED UNTIL HE REACHED
BACK IN THE CAR. I GOT OUT & PULLED HIM OUT. HE HAD NO
WEAPONS AND TURNED & RAN. I PUNCHED HIM BY THE REAR
DOWN. I STOMPED ON HIS FACE/HEAD 1X & WALKED AWAY.
HE SUFFERED FROM A BRUISED EAR, BLOODY NOSE & DENIED EMS
& A MINOR CONCUSSION. IF SOMEONE WAS KICKED BY STEEL
TOES, THEY'D BE ALMOST DEAD. I HAVE PICTURES IN MY
MOTION THAT SHOW HIS INJURY. WHEN HE WAS DEPLOYED,
HE CALLED MY MOTHER & CLAIMED HE WAS SHOT. HE
HAS NO ISSUES PROOFING THIS. HE STATED TO ME IN 2010
AFTER AN ARGUMENT W/ MY MOTHER THAT IF I TOUCHED
HIM EVER AGAIN, HE'D MAKE SURE I NEVER SAW
MY DAUGHTER AGAIN. MY MOTHER CAN VOUCH FOR HIS
VIOLENCE ISSUES W/ FAMILY & HIS EXWIFE W/ HER. HE USED A KNIFE
IN AN ARGUMENT W/ A GUY WHO WAS DATING A GIRL HE LIKED.
IN A RAGE OF JEALOUSY. MY FRIEND KYLE WELSH CAN
VOUCH FOR THAT & RECORD OF HIS MENTAL ISSUES. MY PUBLIC
DEFENDER TOLD ME THAT HE COULD GET ME 3rd degree

ASSAULT / BATTERY & TIME SERVED FOR THE TIME I SPENT
IN COUNTY. MY PLEA SAID "0-3 YEARS NON-VIOLENT 2ND A/B
MISDEMEANOR "W/ "T.S." ON THE TOP OF THE PAPER

INDICATING TIME SERVED. HE TOLD ME ON THE DAY
OF COURT THAT "I AM GOING HOME TODAY. NICK
CHANGED HIS STORY FROM WHAT THE ORIGINAL STATEMENT
SAID & LIED ABOUT INCIDENTS IN TRAP & FULLNESSES HE
HAS. I PLED GUILTY TO 2ND A/B BECAUSE I WAS
IGNORANT OF THE FACT THAT I COULD BE CHARGED W/
WHAT THE WARRANT SAID.

I'VE HAD ASTHMA SINCE BIRTH, I ALSO HAVE SCLIOSIS
IN MY SPINE. I WAS TESTED FOR TB AT J. REUBEN
LONG. IN 11-2005, IN KIRKLAND PRISON IN 7-2006 TWO TIMES.
AT KIRKLAND, I WAS GIVEN A 5 DAY SUPPLY OF AN
ANTI-BIOTIC. IT MADE A RAISED RED BUMP THE SIZE
OF HALF MY THUMB TO SLOWLY FADE. I TOOK A
2ND TEST AND ANOTHER RED MARK APPEARED. ALSO, I WAS ~~NEVER~~
NEVER GIVEN A BLOOD TEST OR SCREENED FOR HIV. I CAN
PROVE THIS BECAUSE THE PRISON WOULDN'T HAVE A RECORD OF
MY BLOOD TYPE. I NEED TO GET TO A DR. OUTSIDE OF THE
PRISON SYSTEM TO GET THESE. I SLEPT W/ A WOMAN BACK IN
3-2005 THAT I BELIEVE IS HIV POSITIVE.

WHILE IN WATERBURY PRISON, I WAS EXPOSED TO AN
INMATE THAT WAS VERY SICK ON 8/18/10. THIS PLACE IS
A FARM THAT HAS NO VENTILATION. ANYWHERE EXCEPT FOR

IN LOCK-UP ON ONE SIDE OF THE BUILDING.
THEY HAVE CELLS W/ A/C INSTEAD ~~OF~~ OF OPEN
WINDOWS W/ FANS ON ONE SIDE SUCKING DUST INSIDE. I
ASKED TO BE PLACED IN ONE OF THOSE CELLS, I WAS
TOLD NO. MED STAFF REFUSED TO OFFER ME AN
INHALER, ANTI-BIOTICS FOR MY TB. OR A DR. VISIT, THIS
PRISON IS COMPLETELY ENGULFED IN SMOKE, DUST, DEBRIS.
IN ORDER TO BREATHE, I HAD TO PUT A TOWEL
OVER MY FACE. I WENT TO MEDICAL, ^{2X} TOLD THEM I
FELT LIKE I HAD THE FLU, FEVER, COUGHING UP COLORED
MUCUS & BLOOD. THEY TOLD ME I WAS FINE & PUT ME ON
A DR.'S WRITING LAST 2 MONTHS LONG. MY BODY FEELS
VERY HOT SOMETIMES. I CAN NOT SPEAK W/ OUT BECOMING VERY
SHORT OF BREATH, I CANNOT WALK A NORMAL PACE, MY
LUNGS HURT & I HAVE A HISTORY OF PNEUMONIA &
BRONCHITIS. I'M LOSING MY APPETITE & VERY TIRED ALL
THE TIME.

WHILE IN J. REEBEN, I WAS SLEEPING ON A THIN
MAT & HARD SURFACE. I BELIEVE THAT SLEEPING ON THE
HARD SURFACES CAUSED A NERVE TO PULL OFF
&/OR A DISK TO SLIP IN MY UPPER BACK. MY BACK
HURTS SO MUCH SOMETIMES THAT IT WILL TAKE MY
BREATH AWAY. I HAVE DEVELOPED A SEVERE CASE OF
EDEMA. STARTED NOTICING IT IN MARCH, I THINK. I HAVE
PAPER COPIES OF ALL MY DENIED SICK CALLS AT
J. REEBEN & WATERBURY, STD/HIV TESTS.

THEY PLACED ME ON "LASIX" WHICH IS A WATER PILL. IT DOES ABSOLUTELY NOTHING FOR ME. I'VE TOLD MEDICAL THRS. THEY ALSO GAVE ME RESPIRIDOL MANY TIMES WHICH HAD MY BLOOD PRESSURE AT 140/119. ADEMA IS SWELLING OF THE BODY PARTS. WHEN I SIT DOWN, MY BUTT GOES NUMB & MY HEAD STARTS POUNDING. WHEN I LIE DOWN, MY LEGS, FEET, HANDS SOMETIMES MY BACKS GO NUMB. I'VE BEEN TELLING MEDICAL STAFF ABOUT THIS SINCE I STARTED NOTICING IT. THE PAST DR'S OFFERED ME NO ADVICE OR TOLD ME IT WAS MY FAULT FOR GOING TO JAIL W/ THESE ISSUES? I HAVE ^{NUMBNESS} SWELLING OF MY FEET, HANDS, FACE & ARMS. MY LEGS & THIGHS & FOREARMS HAVE LOST MAXIMUM MOBILITY. I HAVE SHARP PAINS IN MY LEGS WHEN I LIE DOWN. I BELIEVE MY SCITIZ NERVE IS BEING PINCHED OFF OR A NERVE IN MY LOWER BACK IS SOMEHOW AGGRAVATING VEINS OR NERVES IN MY HEAD. B/C WHEN I LIE DOWN, MY HEART RATE QUICKENS, I BELIEVE MY OPTIC NERVE IS BEING PINCHED OFF B/C MY VISION IS BLURRED. I USED TO HAVE 20/13. NOW I HAVE TO SQUINT TO READ. FROM A ROCK, HAVE TROUBLE DISTINGUISHING COLORS & HAVE TROUBLE SEEING AT NIGHT. MY BACK PAIN IS SO SEVERE SOMETIMES THAT IT TAKES MY BREATH AWAY. IF I AM THIS ILL & MEDICAL CONTINUES TO DENY MY RIGHTS, I'M GOING TO PASS AWAY FROM POSSIBLE HIV/TB (DEFINITE) I WAS TOLD BY NURSES THAT IN ORDER TO GET A PERSONAL DR. OR MED RECORDS, PROVING MY BACK & RESPIRATORY ISSUES, I NEED TO

GO THROUGH AN ATTORNEY. I NEED A BLOOD TEST & TREATMENT IMMEDIATELY. I STAND FOR 20 HOURS AT A TIME TO HELP PREVENT MY NERVES FROM BEING DAMAGED FURTHER. MY ANKLES SWELL UP TO 2X NORMAL SIZE, LEGS TOO.

I FEAR MY LUNGS ARE FILLING W/ FLUIDS. IF I LAUGH, I START COUGHING & SQUEEZING BT APR. I'M SCARED & FEEL PRESSED FOR TIME. I WAS LOCKED UP ON 11-31-13. I'M STRUGGLING TO BREATHE. I WAS TAKEN TO KIRKLAND (COLUMBIA)

PRISON FOR X-RAY ON MY BACK. THE NURSE SAID AFTER TAKING THEM THAT I'M GOING TO NEED A ^{BLOOD TEST} ~~AND X-RAY~~ DAY BY DAY & GET WORSE. I TOOK X-RAYS 1 MO. AGO.

I NEED SOMEONE TO HELP PLEASE CONSIDER THIS & ALLOW ME TO GET AN APPEAL/AMENDMENT OR AT LEAST FILE FOR A "POST-CONVICTION RELEASE" MY MOTHER CAN BE CONTACTED AT 843-457-3323. FATHER AT 843-230-8790

JACQUELINE & PETER ROHRMAN & CAN VOUCH FOR EVERYTHING. I'M IN FEAR FOR MY LIFE. (NOT BEING

ALLOWED THE RIGHT TO PROPER MEDICAL & BEING WRONGFULLY CHARGED FOR A CRIME, I PLED GUILTY TO

WHEN I WAS PROMISED A LIGHTER CHARGE/SENTENCE.

WHATEVER YOU CAN DO, PLEASE CONTACT US & LOOK INTO

THE NATURE OF THIS CRIME & PHYSICAL EVIDENCE & NICHOLAS' HISTORY OF MENTAL ILLNESS. THANKS.

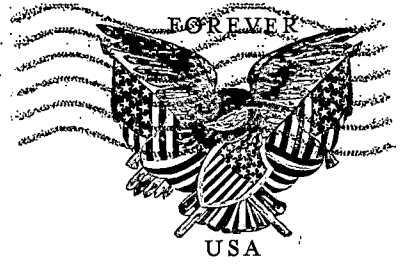
