i started calling the police, then the FBI and Finally

I had gotten a letter from the I.R.S of an \$334.00 deliquent tax that was dated for payment 12-13-2013 and I Reopened a police report on Palmetto bank because of forged Counter checks on an closed account on 12-12-2013 then the next day i had a problem with my leg so i went to the hospital and they did a spinal tap and were speaking of govt and political activity and were telling me they were giving me all these harmful drugs at this Lbgt type facility. It was a very scary visit after the procedure was finished they gave me no meds and said to take tylenol and a german fellow said to go home and spy, and told me i could have migranes. All the different once i got home because this aggressive type of almost cancer consuming treatment came over me and i kept having to go back and forth from greer (greenville) and Spartanbury Regional facilities and they kept saying there was nothing they could do for me so i emailed the whitehouse and called govt agencies to stop this attack from Continuing a fast tracked area of crimes. Once I contacted agencies the attacks decreased and instead of a recovery act, I was re attacked by political figures lobbying the executive branch as russia invaded
