Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Jason James v. State in the Supreme Court on July 25, 2016. Counsel filed the brief of petitioner in the case of Sarah Cardwell v. State in the Supreme Court on July 18, 2016. Counsel filed the brief of petitioner in the case of Ruben Ramirez v. State in the Supreme Court on July 18, 2016.

3. This request is made in good faith, and not for purposes of delay.


4. As indicated by his consent below, counsel for the state graciously consents to or does not oppose this request.


