The affiant states there is probable cause to believe that the defendant named above did commit the crime(s) set forth, and that such probable cause is based on the following facts:


On October 26, 2014 between the hours of 9:00 am and 5:00 pm, while at 2004 Orvid Street, Apartment 3C, located in the City of North Charleston, County of Charleston, State of South Carolina, the defendant, **CURTIS TYRONE WILLIAMS**, did commit the offense of **HOMICIDE BY CHILD ABUSE** in violation of section **16-3-85** of the South Carolina Code of Laws of 1976, as amended. In that the defendant did willfully and unlawfully cause the death of his girlfriend's 3-year-old son while committing child abuse and the death of the child occurred under circumstances manifesting an extreme indifference to human life.

Facts to establish the aforesaid are that on the above date and time, the three year old victim (further identified in the incident report) arrived at MUSC in the arms of the defendant and was declared deceased. The defendant initially stated to the responding officers that the victim began acting lethargic and weak after the victim was given a bath because he had defecated on himself. Crime Scene photographed the victims body and documented several bruises on the victims body to include a large bruise on his left back rib area. An autopsy was conducted on October 27, 2014 which showed the cause of death to be blunt force trauma which caused his spleen to rupture and bleed, therefore causing the victim to bleed to death. The defendant was advised of his constitutional rights, which he waived, and interviewed by Sgt. Lewis and Det. Benton which was captured via audio and video. During the interview, the defendant confessed to "chopping" the victim in his left back rib cage because he did not walk out the bathroom fast enough. When asked to clarify what "chopping" was, he explained and demonstrated a closed fist strike which he delivered to the victims left back rib cage.

Det. Sgt. S. Lewis, MPO L. Cummins, and Det. C. Benton are witnesses to prove same. All this done against the law peace and dignity of the State of South Carolina.
