The Cervical MRI from April 2013 shows disc space narrowing C5-6. The cervical x-ray done on 2/28/2013 does show disc space narrowing C5-6 with small anterior osteophyte. No nerve root compression.

Cervical MRI done on 10/22/2015 shows disc space narrowing C5-6 with small uncovertebral osteophyte. No nerve root compression. No spinal stenosis.

Cervical MRI done on 5/5/2016 shows no nerve root compression. Disc space narrowing C5-6 with small osteophyte.
