Dear Ms. Kitchings:

Please be advised that we sent a letter to the court reporter ordering the transcript for the underlying hearing held on February 16, 2016 on June 23, 2016. The court reporter sent a letter dated June 27, 2016 confirming receipt of our request and asking for a deposit in order to begin working on the transcript, which we mailed on July 11, 2016. Her letter advised that under the rules she has sixty days to complete the transcript after receipt of the deposit and is allowed to request thirty day extensions as necessary. By our calculations the initial sixty (60) days was up on September 14, 2016 (this includes an extra five (5) days for mailing).

This letter is to advise that, to date, we have not received the transcript or notice of any extension and it is our understanding that the thirty day deadline for our initial brief is not triggered until receipt of the transcript.

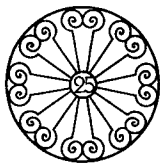
