## ORDER

---

Respondent has moved to correct the record on appeal. The motion is granted. Appellant shall prepare an amended record on appeal. Pursuant to Rule 210(c), SCACR, the amended record on appeal shall include all items designated by the parties to be included in the record under Rule 209, SCACR, and shall be paginated.<sup>1</sup> The amended record on appeal shall not include Appellant's initial brief. Final briefs shall be filed separately from the amended record on appeal and shall include references to the record pursuant to Rule 211, SCACR.

Appellant shall serve a copy of the amended record on appeal on Respondent and file a copy of the amended record on appeal with this court within thirty days of the date of this order.<sup>2</sup> Failure to comply with this order may result in dismissal of the appeal.
