
Please be advised that I represent Mr. Green in the above matter. A Hearing was held on September 7, 2016, in Richland County before Judge Jean Toal.

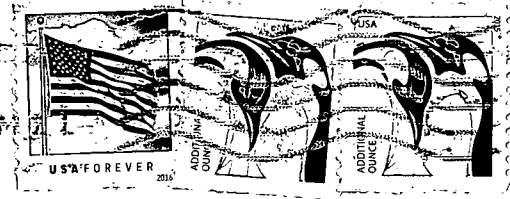
