MOTION FOR EXTENSION





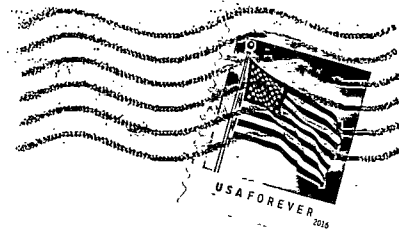
