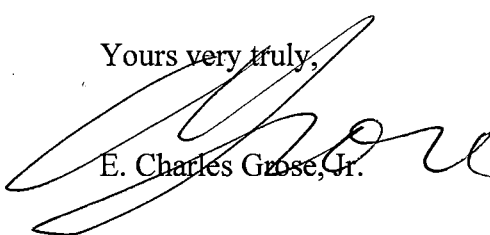
Dear Ms. Kitchens:

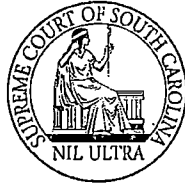

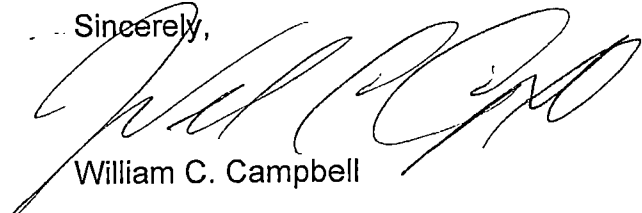

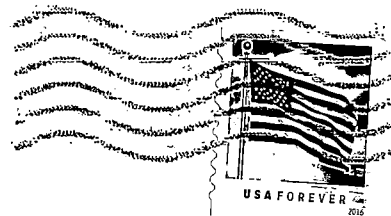
