This is a joint request by all parties to the above-referenced appeal to hold the current appeal in abeyance, pending another anticipated order being issued soon by the trial judge as to a matter currently under advisement. Judge Kimball indicated via email on September 21, 2016, that he would be issuing that order shortly on the remaining matter. It seems likely at least one party will appeal from the soon to be issued order, and it would be the parties' preference for such appeal to be consolidated with the appeal already pending.
