MOTION FOR COSTS


Pursuant to Rule 240 and 222(d) SCACR, Petitioner Rebecca Jackson requests that the costs of this appeal be taxed against the Respondents.

This Court's *per curiam* opinion reversed and remanded the judgment of the Circuit Court, and the Outback Defendants were the respondents in the proceedings at the Court of Appeals. Rule 222(d) provides that a party desiring costs to be taxed must, within fifteen (15) days of the issuance of the remittitur, serve and file a motion requesting that costs be assessed. Having received the remittitur, this motion is accompanied by a signed, sworn and itemized statement of costs incurred in the form prescribed by the Rules. Absent any return to this motion, Petitioners request costs to be awarded in her favor, as well as the attorney's fee of \$1,000.

In accordance with the instructions of Rule 222(e), an itemized statement of costs is attached to this motion.
