
MOTION TO SUPPLEMENT

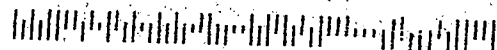
