
- 1) Current counsel of record has prosecuted this Appeal to the Court on behalf of the Appellants, including filing Appellants Final Brief on September 14, 2015.

3) As such, Appellants desire for George D. Gallagher to be their attorney of record and Mr.


Bornemann and Mr. Leventis be relieved from any further obligations on this matter.


WHEREFORE the undersigned counsels pray for an Order from the Court substituting and relieving counsel for the aforementioned reasons.
