our God.. Please Help me Sir.. Please...

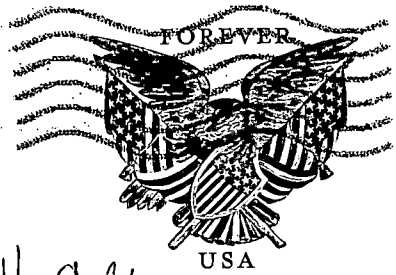
