NOTICE OF INTENT TO APPEAL





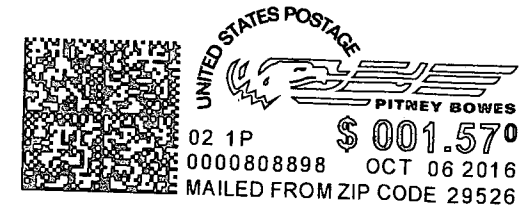
