**PETITION FOR EXTENSION TO FILE
THE REPLY TO THE RETURN TO THE PETITION
FOR WRIT OF CERTIORARI**

The undersigned counsel would respectfully request a **final ten-day extension, until October 27, 2016** in which to file the reply to the return to the petition for writ of certiorari in the above-referenced case. In support of this motion, counsel would respectfully show the Court the following exigent circumstances:

Counsel had an oral argument in the case of The State v. Donte Samar Brown in the Court of Appeals on September 21, 2016. Counsel filed the initial brief of appellant and designation of matter in the case of The State v. Paula Reed Rose with the Court of Appeals on September 14, 2016. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Dennis F. Sanders v. The State of South Carolina in the Supreme Court on September 6, 2016. Counsel filed the initial brief of appellant and designation of matter in the case of The State v. Devionne Devaughn McClain with the Court of Appeals on September 6, 2016. Counsel filed the brief of petitioner and accompanying appendix in the case of Lloyd Wright v. State of South Carolina in the Supreme Court on August 17, 2016. Counsel filed the initial brief of appellant and designation of matter in the case of The State v. Robert Steven Jolly with the Court of Appeals on August 17, 2016.

3. As indicated by his consent below, counsel for the state does not oppose this request.


4. This request is made in good faith, and not for purposes of delay.


