Re: Enclosed Petition For Writ of Certiorari


To whom it may concern:

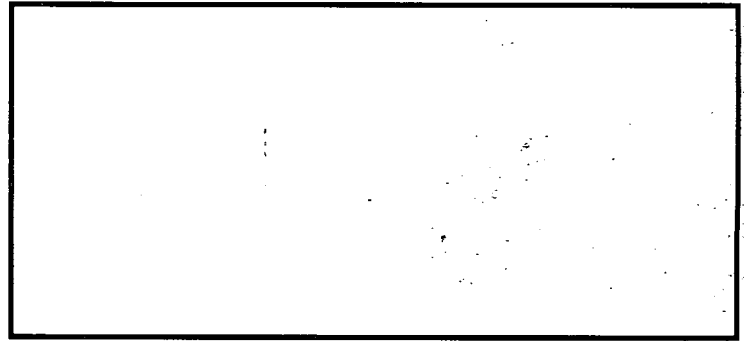

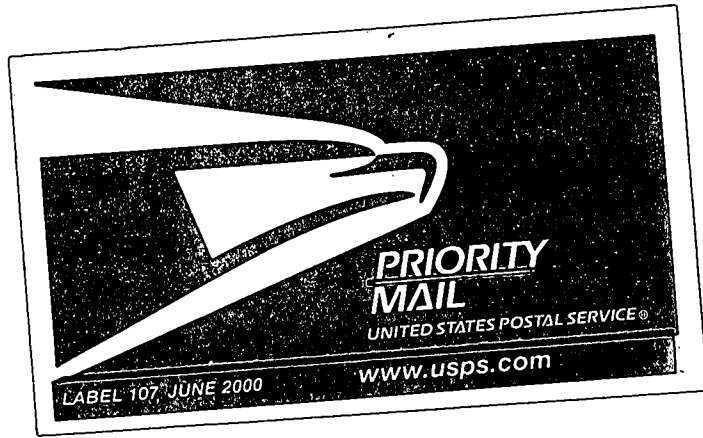
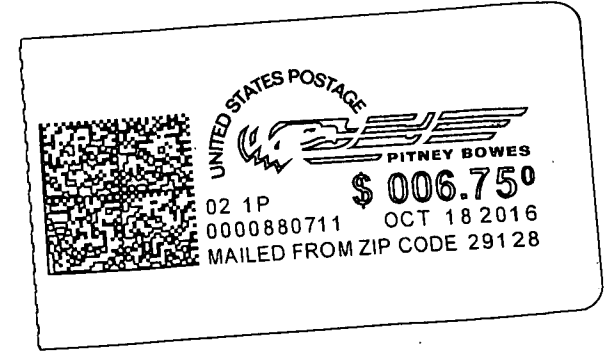
